## A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate Three Hundred and Five Thousand Dollars (\$305,000.00) for the continued operation and regulatory oversight of the Rota Casino Gaming Commission; and for other purposes.

# BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

#### 1 SECTION 1. PURPOSE.

- The purpose of this bill is to appropriate local funds for Three Hundred and
- 3 Five Thousand Dollars (\$305,000.00) for the continued operation and regulatory
- 4 oversight of the Rota Casino Gaming Commission and other needs of the
- 5 municipality. These funds were received by the Municipality of Rota pursuant to
- 6 10 CMC § 12141. This local appropriation is made under the NMI CONST. art. VI
- 7 § 8, cl. 2; 1 CMC §§ 1402–03, and 1408; and 10 CMC § 12103. This appropriation
- 8 is based on the budget request adopted and approved by the 20th Rota Municipal
- 9 Council during its 6th Regular Session, held on August 28, 2025.

1	SECTION 2. <u>APPROPRIATION</u> .
2	Notwithstanding any provisions, statutes, laws or regulations to the
3	contrary, the Rota Legislative Delegation hereby appropriates, from the funds
4	received by the Municipality of Rota pursuant to 10 CMC § 12141, Three Hundred
5	and Five Thousand Dollars (\$305,000.00) to the Rota Casino Gaming Commission
6	(RCGC) for its operations and other needs of the municipality to be used as follows:
7	(a) \$292,000 for the RCGC Operations; and
8	(b) \$13,000 for the payment of salaries of the previous RCGC members.
9	SECTION 3. EXPENDITURE AUTHORITY.
10	The RCGC Chairperson shall be the expenditure authority of the funds
11	under Section 2. Any compensation owed to a former Commission Member shall
12	be paid in accordance with 4 CMC § 9711.
13	SECTION 4. REPROGRAMMING.
14	Notwithstanding any laws, provisions, or regulations to the contrary, funds
15	appropriated under this Act shall not be reprogrammed for any other purpose unless
16	a written justification is submitted to the RLD Chairperson for approval. Three
17	RLD members shall sign the approval of the requested reprogramming.
18	SECTION 5. <u>REPORTING</u> .
19	The expenditure authority shall submit detailed monthly reports showing
20	the expenditure of funds appropriated under this Act. These reports shall be
21	furnished to the Chairpersons of the Rota Municipal Council and the First

1 Senatorial Delegation until all appropriated funds have been fully expended. If the 2 expenditure authority fails to meet this reporting requirement, no further 3 expenditures shall be authorized under this Act until the required reports are 4 submitted. 5 **SECTION 6. SEVERABILITY.** 6 If any provision of this Act or the application of any such provision to any 7 person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or 8 9 circumstances other than those to which it is held invalid shall not be affected 10 thereby. 11 **SECTION 7. SAVINGS CLAUSE.** 12 This Act and any repealer contained herein shall not be construed as 13 affecting any existing right acquired under contract or acquired under statutes 14 repealed or under any rule, regulation, or order adopted under the statutes. 15 Repealers contained in this Act shall not affect any proceeding instituted under or 16 pursuant to prior law. The enactment of the Act shall not have the effect of 17 terminating, or in any way modifying, any liability, civil or criminal, which shall 18 already be in existence on the date this Act becomes effective. 19 **SECTION 8. EFFECTIVE DATE.** 

This Act shall take effect upon its approval by the Governor or it becoming law
