Speaker Edmund Joseph Sablan Villagomez: Thank you, Clerk. With 17 members present, a quorum is duly established. Let the record reflect that Representatives Joseph Flores, Thomas Manglona, and Malcolm Omar are excused for today's session. Before we move to Item No. 2, Public Comments, I recognize the Floor Leader for the suspension of rules.

The Floor Leader moved for the suspension of Rule III, Section 6.

RULE III. SESSIONS AND MEETINGS

Section 6. Notice of Sessions.

Not less than 72 hours prior to convening a Regular or Special Session, the Speaker or a majority of the members of the House, shall file a written public notice of the date, time, and place of a session with the Clerk and post the same at the executive branch administration building and the Legislature's website. When possible, notices under this section shall be given to at least one newspaper of general circulation. Notices shall contain an agenda of items to be considered at the session. Final disposition shall not be taken on any other matter at such session. Once filed as part of this notice, the agenda may only be changed by adding items thereto by the recorded vote of the majority of the members of the House.

INTRODUCTION OF BILL

RULE IX. BILLS, RESOLUTIONS, AND AMENDMENTS.

Section 8. Referral of Bills and Resolutions.

- (a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.
- (b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

The Chair called for recess.

The House recessed at 4:00 p.m.

Recess

The House reconvened at 4:19 p.m.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> We rise back to session. Before going into recess, we were under Item No. 6, Messages from the Governor. And as mentioned by the Clerk, we have two Governor's Communication, Governor's Communications 24-20 and 24-21. The floor is open for discussions and I recognized Representative John Paul Sablan.

Representative John Paul Palacios Sablan: Thank you, Mr. Speaker. Under Governor's Communication, we have two communications before us. That is Governor's Communication 24-20 and 24-21, and both these communications here are up for a vote for an override. Therefore, I want to state for the record my support of voting for an override. As we all know, as elected leaders here, that we are suffering economically on these very trying times. And with these legislations that are before us, that are calling and are promising for revenue to be generated into our CNMI. Therefore, I am in support and I am ready for the vote.

The Chair recognized the Floor Leader.

Floor Leader Marissa Renee Flores: Thank you, Mr. Speaker. And yes, as Representative Sablan mentioned, we have two items up for override, and both are revenue-generating bills that require this body to act. And then it will be sent to the Senate for them to act. But this is our constitutional duty, this is our job, this is what we have to do. While the first communication is directed toward our second senatorial district of Tinian. It is known through the public and here out of mutual respect that whatever happens in the senatorial district, the first senatorial district, and the third senatorial district, locally, there is a mutual respect that we are given an autonomy to grow our economy every which way we fit. However, this bill or this communication also was commented on by our Attorney General, who we also seek guidance from in terms of legislation. And I have a big respect for our Attorney General, because he was elected like us. He has a duty to help navigate and provide his opinion on the constitution and our bills that are being presented forward locally and Commonwealth-wide. If you could just allow me, Mr. Speaker, I think this is very important, because every time we talk about casinos, there is always a bitter pill to swallow. And I have made that very clear with lobbyists, with anybody coming to discuss with me why this bill, or this communication, this override, is so important. And yes, it is true, we are in dire need of money. But what I do not like is when we are desperate and we are now forced to make a decision because we are desperate once again. And every time we are desperate, it always seems that we come back to the casino all the time. For some reason, it is just that. And I will tell you why, because it is lucrative. There is money to be made everywhere, and in this one, this is the internet. So, you have a developer, you have an information technology guy, and you have all kinds of people working behind the scenes making money, somehow. But I want to make it very clear to my colleague from Tinian that as you, if anything happens with this bill today, the Commonwealth will also gain from the business's gross revenue. Now I was listening to the two comments received from Mr. Norita and Mr. Vin Armani saying that they are ready to go at the press of a button. People are watching, wonderful. That is great. But as a representative, I do not like to be pushed to a corner to make a decision based on fear. So, with that said, Mr. Speaker and esteemed colleagues, we often hear about the virtues of quick thinking and seizing the moment. We celebrate those who make split decisions, trusting their gut and reacting swiftly to changing circumstances. But while there is a time and a place for rapid response, particularly in times of crisis, we must acknowledge the significant risk of potential pitfalls of impulsive and reactive decision-making, especially when it comes to the long-term success of our Marianas and the well-being of our constituents. Today I want to talk about the other side of the coin, about the importance of careful planning, thoughtful deliberation, and patience to see our decisions through. In the realm of governance, these qualities are not merely virtues. They are essential for effective leadership and enduring process. In the fast-paced world of enduring politics, we are often pressured to act quickly. We fear missing the news cycle or being seen as indecisive or slow. But this obsession with speed can often lead us astray. Impulsive decisions made without careful consideration of all the ramifications are more likely to be based on incomplete information, flawed assumptions, and fleeting political passions. We might feel a rush of accomplishment in passing a bill quickly, a sense of political victory in responding swiftly to a crisis. But the consequences of these decisions can linger long after headlines have faded, potentially derailing our long-term goals for the Marianas and undermining public interest in our institutions. Reactive decisions made in response to immediate stimuli or external pressures suffer from a similar flaw. Instead of being driven by core values or constitutional principles and a long-term vision for the Marianas, they are dictated by the crisis of the moment, the demands of special interest groups, or the shifting of political

opinion. We become like leaves blown by the wind, constantly reacting to the latest crisis or demand without ever taking the time to chart our own course. This reactive approach can leave us feeling like we are constantly putting out fires, never truly in control of our legislative agenda, and ultimately failing to address the root causes of the challenges facing the Marianas. Slow, deliberate planning, on the other hand, which they have mentioned they have done, offers a powerful antidote to these dangers by taking the time to carefully analyze a situation, to thoroughly vet all policy options, and to consider the potential consequences of our actions across different sectors of society and across future generations. We can make choices that are more aligned with the longterm goals and values of the Marianas. We can seek out diverse perspectives from experts, stakeholders, and the public; conduct rigorous research; and ensure that our decisions are based on the best available evidence. We can anticipate unintended consequences, identify implementation challenges, and develop robust contingency plans to mitigate risk before they arise because, once again, here we are. We can ensure that our policies are consistent with the Constitution, uphold the rule of law, and reflect the fundamental values and principles that underpin our democracy. We can lay the groundwork for sustainable growth, build strong and resilient communities, and create a future that is both prosperous and just for all. But patience, patience is perhaps the most crucial element of this approach. It requires us to resist the urge for instant gratification to delay immediate political victories in favor of the greater long-term gains of the Marianas. It demands that we trust the legislative process even when the path forward is complex and the results are not immediately apparent. This kind of patience is not passive. It is not about waiting for problems to solve themselves, it is about actively working towards our goals with a steady focus and unwavering commitment to the common good. It is about having the self-discipline to stay the course, to engage in constructive dialogue, and to build consensus even when faced with partisan gridlock and public pressure. In a world that often celebrates speed and impulsivity, let us not forget the enduring power of slow, deliberate planning and the vital importance of patience in governance. By taking the time to think carefully, to act thoughtfully, and to persevere patiently, we can make decisions that not only serve our immediate political needs but also pave the way for the long-term security, prosperity, and well-being of our Marianas. Let us strive to be lawmakers who are remembered not for the speed of our actions but for the wisdom, foresight, and enduring impact of our policies. With that said, I pressure and I challenge my colleague from Tinian. Should this body decide in favor of this override, sir, I plead with you that the lines of communication open, remain open, and that any dialogue on business gross revenue come to Tinian, that there is a consequence for a failure to do so, and that anybody that challenges the system that is made to prohibit illicit activity and any other activity that comes with this i-gaming be prosecuted. Attorney Hines, you are right there sitting in. I am sure you can hear this. Follow this carefully because our people are done with bondan fina 'gaga, chadik enao na impulse, hafa tu mananai amyu, tu asu. But my loyalty is to the people. I will make that very clear. Tinian, this is your responsibility. But our constitution says that when we have to override a governor, it requires all of us. Even those not living in your district. So, put fabot, I ask for your indulgence. And I ask that you, please, advocate for everybody now. Because now, we are voting for this override that pertains to the people of Tinian. Thank you, Mr. Speaker. I yield.

The Chair recognized Representative Patrick Hofschneider San Nicolas.

Representative Patrick Hofschneider San Nicolas: Thank you, Mr. Speaker. Madam Floor Leader, this is not only for Tinian. I will tell you that. This is for the whole Commonwealth. And overriding

this senate local bill, it is a forward-looking measure that gives our island and our commonwealth the legal infrastructure to enter a global digital company through standalone internet gaming licenses and the creation of Tinian stablecoin. This is not a rushed thing into unregulated digital wireless. This is a bill about transparency. This is a bill about accountability and modern financial infrastructure. It is about building an economy within the commonwealth. It is about the number of flights landing in the Commonwealth or the rise and fall of tourists coming in. It is about taking control of our economic future in a way that is legal, auditable, and competitive with international standards. Tinian stablecoin is an envision in this bill. It is not speculative cryptocurrency; it is a virtual currency that will be issued and regulated by the municipality, designed to enable transparency and secure, traceable online wagering. Every transaction will be recorded, and every movement of funds will be accounted for. This will be the financial integrity embedded in code. With a stablecoin, we will give operators and regulators in the second senatorial district a clear. tamperproof financial trail, enhancing our reputation for oversight for the whole Commonwealth and enforcing the legitimacy of our gaming industry in an era where financial transparency is key to international compliance. And this will be our competitive edge. Dependency, let us speak about it honestly, Madam Floor Leader and members of this body, the Commonwealth is facing a deep economic crisis. Legacy businesses are closing down, tourist arrivals have plummeted, air service is unreliable, federal support is diminishing, and our islands are no longer waiting for solutions to come from outside. Through the enactment of this Senate Local Bill No. 24-1, the Second Senatorial District will have the legal framework and digital infrastructure to improve more throughout the Commonwealth, not only Tinian. And as a political will to lead this frontier, let me just put this one simply, we need this legislation to unlock our potentials. This bill does not depend on walking tourists or federal subsidies. It builds a digital industry generating revenue from licensed jurisdiction. Mr. Speaker and colleagues, honestly, this is more than a bill. This is a blueprint of economic resilience, a strategy to survive and thrive in changing the world, a call to embrace innovation. While demanding transparency and regulatory oversight, I ask each and every one in this chamber to vote yes to override the veto of this local bill. And let us stand together, not only for Tinian but for the entire Commonwealth's future. Let us do it with confidence, vision, and purpose. I ask each and every one of you to vote yes for this override. Mr. Speaker, thank you, and I yield.

The Chair recognized the Vice Speaker.

Vice Speaker Diego Vincent Fejeran Camacho: Thank you, Mr. Speaker. Colleagues, this will not be an easy vote. We have been asked to override the governor's veto of a bill allowing Tinian to launch online gaming with a stablecoin system. And it is a big move that comes with a big risk. We have three options today: yes, no, or abstain. A yes supports a new economic direction, and a no says the risk is too high. Abstention says we are not ready, and I have considered all three. Tinian is asking for the chance to try something different, and we have seen what happened to the Tinian Dynasty. Big promises and bigger collapses. We have seen it again with IPI on Saipan. Lavish development, little accountability, and lasting consequences. Like that big white elephant down there in precinct three. Lessons were learned, and we must make sure this online gaming venture is different. At least this time it is not brick and mortar. No buildings, no excavators, no land giveaways, and just a digital platform. This proposal is local and does not cost the Commonwealth a dime. I realize that no technology regulates itself either. Oversight will matter from both the regulators and the legislature. And if it goes off course, if it passes and it goes off

course, we need to be prepared to hold wrongdoers accountable. That is our job here. They are not asking for guarantees, they are asking for a fair chance to move forward. So, here are my choices, vote no and block a legal, homegrown initiative with no better option on the table, abstain and delay the decision while Tinian and the rest of the Commonwealth waits, or vote yes because if Tinian is ready to try, then we are ready to monitor the risk. The risk is worth it. If we keep waiting for a perfect solution, we will be waiting forever. Somebody said a few weeks ago, "No one is coming to save us." If Tinian is ready, let us not hold them back. If Tinian wins, the whole CNMI wins. Mr. Speaker, I am waiting for the vote.

The Chair recognized Representative Denita Kaipat Yangetmai.

Representative Denita Kaipat Yangetmai: After going through a heavy discussion and getting educated, I have decided to vote "yes," rel override yel. Bwe igha Tchiliól mille re tipeli internet gaming yel. Nge mille ghatchul nge ngare e tooto bwe e successful, ghiisch mille sibwe bwal yaya. Alongaló falúw loll Commonwealth yel rebwe bwal yaya. Siya lúghu ngalir Retchuliól bwe rebwe ngalleev ghiisch yaasch share. Millel nge eew revenue bill. Thank you, Speaker.

Translation: After going through a heavy discussion and getting educated, I have decided to vote "yes" on this override because the people of Tinian support this internet gaming. And the good thing about it is if it becomes successful, we would also get a share. All of the Commonwealth would benefit from it. Let us give the people of Tinian the green light with this industry so we can all benefit from it. This is a revenue generating bill. Thank you, Mr. Speaker.

The Chair recognized Representative Daniel Iwashita Aquino, Jr.

Representative Daniel Iwashita Aquino, Jr.: Thank you, Mr. Speaker. I just want to inform Representative San Nicolas that I too will be voting yes on both overrides. As far as the internet gaming, that is a billion-dollar industry, and I would also like to have sports betting, like sports betting. Bet on anything. That is the most lucrative business that is out there. As far as Tinian, I have family there, both on my father's and mother's side. So, my decision is to just say yes to help the people of Tinian and to help the people of the CNMI. Thank you.

The Chair recognized Representative Ralph Naraja Yumul.

Representative Ralph Naraja Yumul: Thank you, Mr. Speaker. I, too, would like to support the second senatorial district. I have been working, actually, with the developer since the Twenty-Second Legislature, when I tried to introduce i-gaming in the CNMI. However, because the CNMI, or Saipan, was not popular at the time. So, we had a second win. When the bill was introduced in the second senatorial district, which allowed gaming there, it was a lot easier. And I agree with them coming from the Senate side or that side of the house, supporting it makes it a lot easier. This is to allow digital gaming platform, there are going to be regulatory bodies out there. We still have to deal with FinCEN (Financial Crimes Enforcement Network) and all those digital platform regulators. We still have the Department of Finance. I believe the Department of Finance is doing a good job. I remember when we did pass the e-gaming. I did not support it at first, but now there is an industry. The Department of Finance is regulating it. They are collecting the data, and I have

no doubt that they will hire additional employees to ensure that the transparency between the company that is going to be handling this will be very clear with us. With that, Mr. Speaker, I am ready for the vote.

The Chair recognized Representative Julie Marie Atalia Ogo.

Representative Julie Marie Atalig Ogo: Thank you, Mr. Speaker. As a representative of the first senatorial district of Rota, I stand in strong support of overriding the governor's veto of Tinian's Local Law 24-09. This measure was enacted by duly elected leaders of the second senatorial district, who are best positioned to decide what is right for the people and their island's future. Like Rota, the people of Tinian voted for the casino industry as a means to drive economic activity and create jobs. For years, both our communities have worked to jumpstart this industry, not because it is perfect but because it presents a viable opportunity to uplift our local economies. We understand the risk, but we also understand the needs of our people. We believe in building the right safeguards while still moving forward. The Tinian stablecoin is a creative and forward-thinking step toward making the casino industry more secure, transparent, and competitive in a changing global economy. More importantly, it presents the kind of innovation that local leaders must be allowed to pursue on behalf of their constituents. As a representative from Rota, I share the same sentiment as the second senatorial district. Each senatorial district knows what is best for their people. I fully support overriding the veto and encourage my colleagues to stand in solidarity with Tinian's leader and their vision to bring economic opportunities home. Thank you.

The Chair recognized Representative Blas Jonathan "BJ" Tenorio Attao.

Representative Blas Jonathan "BJ" Tenorio Attao: Thank you, Mr. Speaker. And thank you, colleagues, for sharing your points of view in regard to the governor's communications. But before we forget, we also have another Governor's Communication No. 24-21. And I am respectfully asking the colleagues to please support the override on the communication for the mere fact that the governor's message to the legislative branch is contradictory to his actions in disapproving certain sections of House Local Bill No. 24-3, D2. The governor's communication or submission of why he line-item vetoed sections, and I quote, "The bill does not contain any substantive findings or purpose statements defining the intent of the legislation to ensure that the funds are used for public purposes." At the same time, he allowed multiple sections in the legislation to be approved that did not have the substantive statement, I mean, purposes of why those monies should be used or how they were going to be used. But yet disapproved certain sections. So, I ask, colleagues, if we can support the override on Governor's Communication No. 24-21 just through the inconsistency of the governor's message and his actions on the legislation itself. As for Governor's Communication No. 24-20, I support the override on his specific legislation as well. For the fact that in 1999 the people of Tinian had decided, through a referendum, decided to legalize casino gambling on the islands of Tinian and Aguiguan, the second senatorial district. And in that referendum, it was inclusive of internet gaming. Well, the internet, maybe at that time for the most of us, we did not even know existed. They had it in there because they followed suit with what the state of Nevada had provided for their casino gambling in their respective state. In that same referendum, the people of Tinina voted on including a section that would allow its leaders to make amendments. And in this case, it is the leaders from Tinian that made amendments to address what the referendum needed to upgrade for different types of gaming industries in the second senatorial district. It is just unfortunate that when it comes to something that is vetoed on the local, for the local legislation, both the House and the Senate have to act on it. And it puts, at least on the House side, the members from the first and second senatorial districts at a disadvantage because there is only one member. And that one member has to work ten times harder than the members from Saipan to ask for an override. Because now you have to satisfy nineteen, eighteen at the very least, right? But nineteen to get the override going. So, since the people of Tinian voted on a referendum that allowed the leadership of Tinian to make changes to that referendum, and these are actions taken by the leadership, I think we should support that at the very least. Let them try it. It is allowed there. I believe Rota's referendum allows the same thing. And if Rota decided to do it, let them do it. The people have spoken in their respective senatorial districts. So, allow them to invest in themselves. At the end of the day, like the vice speaker said, it does not matter where, but if that respective municipality wins, then the CNMI wins in the end. With that being said, I ask for your support and an override for both communications. Thank you for the time, Mr. Speaker.

The Chair recognized Representative Angelo Atalig Camacho.

Representative Angelo Atalig Camacho: Thank you, Mr. Speaker. Real quick, I just want to basically share my experience during these two terms. I guess in the House, in the office, myself and several other members have gone through two, I believe, two budget sessions already by far. And we all witnessed the difficulties and the struggles in properly funding each senatorial district. That being said, I strongly believe in this bill, and I feel it will succeed. I am just hoping it can basically sustain itself. I just see a lot of benefits to this bill. There are some flaws, if you will. However, everyone has their sentiments and different points of view on this bill. I just see more potential in it. So, I think I made a momentum. I am ready to vote as well. Thank you.

The Chair recognized Representative Vincent Raymond Aldan.

Representative Vincent Raymond Aldan: Thank you, Mr. Speaker. I do support both these bills, especially for the Tinian gaming. And this is, I mean, although this is not going to technically affect the whole entire CNMI. But I really do hope that the leadership in Tinian and the people in Tinian, please do not—I am asking you, please do not forget all the things that have happened before when it comes to casinos. We have the dynasty that fell apart, and we are still suffering. Tinian is still suffering, and we still have IPI (Imperial Pacific International). We, and I agree with my colleague, Chairman Angelo, do not have all the money in the world to divvy up to all the senatorial districts. And I really do hope, and I really do pray and wish, this thing works out. Because if it does, if we have learned anything from the past, it is that corruption, under-the-table dealings, favoritism, and all of those things do not work out. Everything has its pros and cons. And I am pretty sure that we are not blind to see that when we start hiding information that rightfully belongs to the public, things tend to fall apart. Is it too much to ask that the leadership of Tinian be open to their people and to the community to show everything to make sure that everything is moving the way it is supposed to move? Because if we have not learned anything from the Dynasty fiasco or the IPI fiasco, we have not learned anything at all. And if you truly are suffering, the whole entire Tinian community is suffering, and we do not have the money to support it. This is your chance. And I hope it works out. I am pretty sure that we could all work together to try to make things better. I just wish you guys the best, because evidently, there is no other plan. I have not seen anything come out of the governor's mouth. And that makes me mad. So, I hope I hear

something this coming SOCA. But whatever. Sometimes we have to do things that are not popular. But if that is the only road we have left, then that is the only road we have left. So, thank you, Mr. Speaker. And I do support the two overrides.

The Chair recognized Representative Roy Christopher Aldan Ada.

Representative Roy Christopher Aldan Ada: Thank you, Mr. Speaker. I think a lot has been said already on the table. I do share a lot of the sentiment that was said, most especially from our floor leader and our vice speaker. It is somewhat of a risk. But I think that the benefits outweigh the risks. With that, I would like to commend Tinian, second senatorial district, and the two gentlemen that came up before us in public comments for taking a proactive approach to this movement. With that, I support both bills before us to veto, I meant override. I am sorry. To override. And with that, I move to end the discussion and go to voting. Thank you, Mr. Speaker.

Several members on the floor voiced "objection."

The Chair recognized Representative Joel Castro Camacho.

Representative Joel Castro Camacho: Thank you. And my apologies to my colleague, Leader. I was not going to talk, but apparently everyone is talking. But I just wanted to share that I actually was in offense of this specific override because, one, obviously there was an opinion from the Attorney General, but I do see the need. Every week, we are hearing some bad news. T'way is cutting down their flights or suspending their flights in July, I believe, and then we have Jeju that is cutting down from three flights to one flight. Hearing of Elan cutting and DFS closure, it is just nonstop. What we need is a new cash infusion, and we are hoping, colleague from Tinian, you will pave the way and show us that there is a better way and there is a potential industry that can benefit not just the second senatorial district but the CNMI as a whole. Thank you.

The Chair recognized the Floor Leader.

Floor Leader Marissa Renee Flores: I know Representative Ada wanted to end this discussion, but I objected only because. Thank you, Representative Camacho, for keeping this communication open. Representative from Tinian, I want to have my last word that you please put fabot. I read your bill. It is a great bill. But for a long time too, the first and third senatorial districts being the most populated of all of the districts in the Commonwealth, our people in our third senatorial district have also sacrificed. Unfortunately for Rota, they have yet to try to share because they have not made it there. But I think with this bill and with your leadership, I hope, munga dei malefa ñami gimi gi precinct three put fabot. Sa for a long time insubi all senatorial districts, and all I ask, asu i senatorial district one, sa miyu nadu na salapi. You are talking about millions, hundred millions, billions, even trillions, maybe. But I think if you can spread it out outside of BGR, maybe another thirty percent, this way would be nice. Lao, take it up with your leadership. I would really appreciate it. Thank you, Mr. Speaker.

The Chair recognized Representative Raymond Ulloa Palacios.

Representative Raymond Ulloa Palacios: Thank you, Mr. Speaker. Baihu finu Chamorro-ha, noh. Pot ha Represesenta lokkue' lai si Patrick San Nicolas esti sa guaha lokkue' chelu-hu dos sumasaga Tinian ya put fabot bota lokkue' esti, sa man sasaga tana'hi, tana'hi yu na mana sina. Yo chagi, håfa para ta lie'e para sia sa dupusiha? Pues finu Donald Trump nei i-lekkna na, håfa yi ilek-ña, "leave i sanction gi i Siria" pues ta chagi ta gui lokkue' ta na'i chance.
