Representatives John Paul Palacios Sablan: Thank you, Mr. Speaker. On the Conference Committee Report No. 24-1, your conference committee team, which encompasses myself, Representative Blas Jonathan Attao, Representative Vincent Aldan, and Representative Joel Camacho, had met with our counterparts' conferees from the Senate. Just a brief history for the members and for the viewing public, since the inception of this bill itself that was offered to this august body by yourself, Mr. Speaker, when it reaches the Senate with the Senate amendments, that version had three main changes. The first change we agreed upon was deleting the word "airport" in all subsequent subsections within both versions. The second amendment that we did was put clarification on Section C, which the Senate version text talks about employees at "40 hours per week." What your committee had done with the Senate committee was put the text regular full-time hours so that we can entertain staff from CPA (Commonwealth Ports Authority), such as the ARFF (Aircraft Rescue & Firefighting) section, where normally their regular work hours are not actually 80. They start at 96, and anything beyond that is considered overtime. We also put what you see in Item D on the Senate version; we repeatedly insert it in Section 3. So that there is continuity in how the CPA can conduct this usage of funds, they first tackle whatever is necessary with the existing bonds that need to be paid before they can unilaterally use these funds to help the airport operations. So, with that, if there are any questions from the members on this work that both comfreys have agreed upon, we stand ready to answer your questions. Thank you, Mr. Speaker.

The Chair recognized Representative Blas Jonathan "BJ" Tenorio Attao.

Representative Blas Jonathan "BJ" Tenorio Attao: Thank you, Mr. Speaker. In addition to what our Chairman for your conferees had mentioned the language of reappropriation, or the reprogramming of funds, we changed that language to transfer of funds so that they do not directly obligate the funds so that they can go back down to the seaport. We would like to thank our Senate counterparts for their time and their understanding when we deliberate on the issue regarding the CPA needs. We are also very fortunate that the Chairman of the board and their controller were part of the conference committee as we broke into the Committee of the Whole. They were able

to explain why those changes were needed or why the original version was really the version they were hoping was going to pass the Senate. But the Senate, credit to their credit, also included language that actually would assist CPA down the road in making sure that when they do transfer funds from the Seaport to the Airport, they do address the obligations, the bond obligations, and all the insurance obligations prior to touching the man-hours. Because we all wanted the manhours to be the priority. Unfortunately, without addressing the mandates from the FAA, they would never be able to get the man-hours. So, we were able to address that with the language that we agreed to during the conference committee to allow CPA to work with their vendors through additional funds that they will be moving up from the Seaport. Work with their vendors, as well as the bonding agencies. So that they can free up some funds and get their employees up to fulltime work hours. CPA, as we know, they have actually been on austerity for almost three and a half years. Maybe going on four years. So, this would actually assist them in getting back into their full work hours and hopefully help them with their buying power that would trickle down to our economy here in the Commonwealth. So, any questions from the members? If you have any questions, we stand ready to answer. Thank you, Mr. Speaker, for allowing us to represent the House as your conference committee. Thank you.

# SPEAKER OF THE HOUSE

Commonwealth of the Northern Mariana Islands

Mister Speaker and Honorable Representatives,

My name is Vin Armani. I am the President of the Trade Council of the Marianas. Today I am honored to have the opportunity to give public comment to this distinguished body to urge the immediate passage of SB 24-16, the Foreign Corporation Liaison Act and SB 24-17, the Economic Incentive District Renaming Act. Both of these bills come before you today with a recommendation for passage by the House Commerce Committee.

The economic crisis we are experiencing in the Commonwealth deepens, with no signs of abating. The Marianas Variety's top story today is that visitor arrivals are down 36% year-over-year. We no longer have the luxury of not throwing every resource we have at economic diversification. Every stakeholder who has been pursuing the goal of economic diversification over the past years can attest to the fact that it is technology companies, participating in the digital economy, that are the "lowest hanging fruit" to attract to CNMI. The two bills I come before you to support today are crucial to our being able to harvest new industries to feed the people of the Commonwealth.

SB 24-17 the Economic Incentive District Renaming Act represents an important step toward properly branding CNMI as a destination for highly profitable businesses with a low environmental footprint. It renames Free Trade Zones and the Free Trade Zone Authority to Economic Incentive Districts and the Economic Incentive District Authority, respectively. The renaming is a modernized branding that better fits with the original intent of the Free Trade Zone Act of 2000, which says in its Finding and Purpose that "illustrative examples of [...] desirable business activities would be: production of computer hardware and software, licensing and distribution of intellectual property, computer programming services, database storage and retrieval, [and] financial and trade related services." The Trade Council urges immediate passage of SB 24-17, and passage of local bills in the three legislative delegations, pursuant to The Free Trade Zone Act of 2000, to designate key areas as Economic Incentive Districts. I also urge members of this body to please encourage the Governor to resubmit his nominees for the Economic Incentive District Authority for confirmation by the Senate.

SB 24-16 addresses a major issue that it seems no one is talking about. Within the CNMI Government, there is no single individual whose primary job description is attracting and retaining businesses, currently located outside of the Commonwealth, that could be incentivized to relocate.

While Public Law 22-1 gave CEDA the authority to promote and encourage foreign investment, it did not give it a mandate to do so. In other words, CEDA can act to support economic diversification, but there is no law stating it must or specifying what that responsibility consists of. SB 24-16 addresses this important economic blindspot by establishing a position, the Office of the Foreign Corporation Liaison, within the executive branch, with the sole mandate of removing as much friction (almost all of which is currently within the executive branch) as possible from the process of attracting new taxpayers, new revenue for our CNMI government, and new private-sector employment for our people.. This is not duplicative of the efforts of CEDA, rather it enhances those efforts in significant, pragmatic ways. The Trade Council urges immediate passage of this bill and urges this body to appropriate significant funds so that global experts in this field, with proven track records, can be brought in to staff this office. This is the Commonwealth's salesforce, so get the best there is.

These bills were introduced over five months ago and have now moved through both the Senate and House, including receiving hearings in committee. The time to act is now. I thank you for your immediate passage of these bills and your support of the future economic prosperity of the Commonwealth.
