**A SENATE RESOLUTION**

To adopt the Interim Rules of the Senate for the Twenty-Fourth Northern Marianas Commonwealth Legislature.

1       **WHEREAS**, Article II, section 14 of the Constitution of the Northern Mariana Islands  
2 requires that the Senate shall promulgate rules of procedure; and

3       **WHEREAS**, the Senate of the Twenty-Fourth Northern Marianas Commonwealth  
4 Legislature has convened this 13th day of January, 2025; and


5       **WHEREAS**, the Senate must adopt rules of procedure to conduct the People's business;

6       **NOW, THEREFORE, BE IT RESOLVED**, by the Senate, Twenty-Fourth Northern  
7 Marianas Commonwealth Legislature, that the Senate hereby adopts its Interim Rules of the  
8 Senate and affixed hereto; and

9       **BE IT FURTHER RESOLVED**, that the President of the Senate shall certify, and the  
10 Senate Legislative Secretary shall attest to the adoption of this Resolution and thereafter the  
11 Senate Clerk shall transmit certified copies to the members of the Senate, Twenty-Fourth Northern  
12 Marianas Commonwealth Legislature; to the House of Representatives, Twenty-Fourth Northern  
13 Marianas Commonwealth Legislature; and to the Honorable Arnold I. Palacios, Governor of the  
14 Commonwealth of the Northern Mariana Islands.


