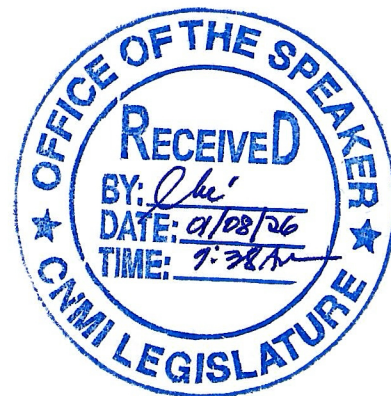

 - a. **HB 24-48:** To adjust the 1992 salary cap of executive directors to a 2025 inflation-equivalent amount.
 - b. **HB 24-58:** To amend 4 CMC § 1305 to exempt services and the sale or exchange of securities and other similar assets from gross revenue tax; to amend 4 CMC § 1708 to allow rebates for exempted activities; to repeal 4 CMC § 1712; and for other purposes.
 - c. **HB 24-72:** To impose a remittance transfer tax within the Commonwealth of the Northern Mariana Islands equivalent to the federal excise tax under 26 U.S.C. § 4475, to ensure equitable revenue capture from outbound remittances, to strengthen compliance with federal fiscal policy, and for other purposes.
 - d. **HB 24-73:** To provide a nonrefundable tax credit to taxpayers who make donations of cash or food supplies to qualified community-based service organizations.

- e. **HB 24-77:** To amend the operating budget and scope of operations of the Office of Grants Management and State Clearinghouse (CNMI OGM-SC); and for other purposes.
- f. **SB 24-18, SD1:** To amend 1 CMC § 2803 regarding the budget submission of the Department of Public Lands; and for other purposes. *(See Sen. Comm. 24-14)*
- g. **SB 24-19:** To amend 9 CMC § 2208(d) to authorize motor vehicle licensure to all residents of the Commonwealth of the Northern Mariana Islands. *(See Sen. Comm. 24-39)*
- h. **SB 24-32, SD1:** To amend 2 CMC § 3551 to change the expenditure authority, management, and control of the solid waste sub-accounts for the First and Second Senatorial Districts; and for other purposes. *(See Sen. Comm. 24-16)*
