## General Duties:

• Conducts budget analysis, monitors agency and institution budgets, and prepares related reports;

- Provides information and assistance on the status of legislative proposals and measures, budgetary and fiscal practices, and prepares summaries and explanations of budget-related reports and proposed legislation;
- Provides assistance in analyzing departmental budget requests, including necessary documentation, investigation, and related budget impact studies;
- Provides technical assistance to the Legislature on cost-benefit analyses or fiscal reports on proposed legislation or current programs;
- Conducts fiscal and general research for Legislative Committees and for individual legislators, prepares reports and analysis on findings, and presents alternative solutions for consideration;
- Drafts bills, resolutions, reports, and amendments;
- Makes oral presentations and responds to questions regarding state budget and fiscal matters;
- When necessary, attends budget hearings, committee meetings, and legislative sessions; and
- Performs other duties as directed.

## Qualifications and Requirements:

- Must possess a Bachelor's degree from an accredited college or university with a major in Public Administration, Business Administration, Accounting, Economics or related field with two years experience; or possess eight years of relevant work experience;
- Possess ample knowledge of the legislative process and the CNMI government budgeting process;
- Excellent research, analytical, and strong writing skills; and
- Ability to produce results within limited time frames and work under pressure on a daily basis.

Education requirements may be substituted with related experience
